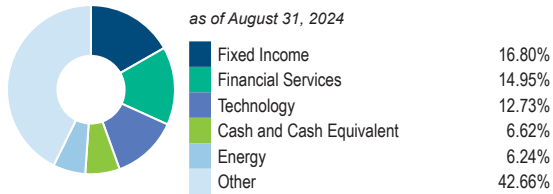
ASSET ALLOCATION

as of August 31, 2024



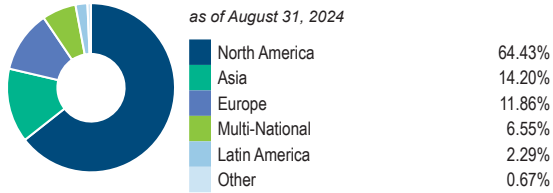
SECTOR ALLOCATION

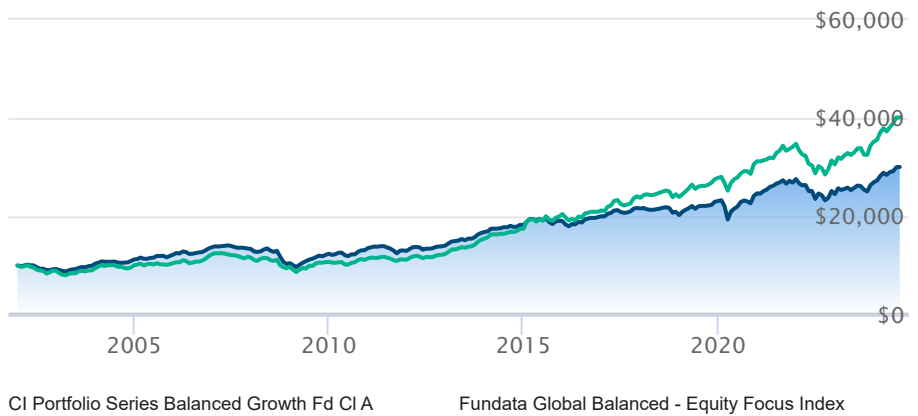
